In accordance with Section 63 of the *Local Government Act 1989* a person elected to be a Councillor is not capable of acting as a Councillor unless he or she has read the Councillor Code of Conduct and, in accordance with sub section 3, made a declaration stating they will abide by the Councillor Code of Conduct.
