Permit Conditions

- 1. NO HORSES on the beach 25 December to 1 January (inclusive), 26 January and Good Friday to Easter Monday (inclusive) each year.
- 2. Time restrictions during Victorian Summer and Easter Public School Holidays with a valid permit
 - Professional Trainers must be off the beach by 9.30am (with the exception of dates above).
 - All other riders permitted between 9.30am and 11.00am (with the exception of dates above).
- 3. At all other times horses are permitted on the beach as long as they have a valid permit.
- 4. Permit holders agree to maintain a public liability policy of insurance for an amount of not less than \$10m with an insurer authorised under the *Insurance Act 1973*.
- 5. All horse excrement must be removed from the beach, access track and carpark areas and taken home. Penalties may apply Bass Coast Shire Council Local Law No. 1 Neighbourhood Amenity 2012.
- 6. Parking in designated permit parking area only (see map). Relevant parking controls for horse floats and truck in Norsemens Road and surrounding streets must be adhered to.
- 7. Horses must be kept at a safe distance from other beach users and slow to walking pace within 20 metres of pedestrians. Riders to be courteous to other beach users at all times.
- 8. Payment of the fee and issuing of a permit constitutes a permit holder's agreement to abide by the conditions above.
- 9. Failure to adhere to permit conditions will lead to permits being revoked with no refund.
- 10. The supplied laminated permit must be visible in each vehicle whilst in the Foreshore area. Lost laminated permits are to be replaced at the permit holder's expense. Replacement laminated permits (\$10 per permit) are obtainable by applying to the Community Safety Team.
- 11. Permits are strictly non-transferable.
- 12. The permit period is from 1 December to 30 November each year.

Considerations for applicants

- There is limited parking available for permit holders and no toilet, water or other facilities are available at this location.
- Horse riders don't have the exclusive use of the beaches and are expected to share the beach
 with other users, dogs are allowed on the beach north of Norsemens Road on a leash and off
 leash north of O'Connor Road.
- Horse riders must take in to consideration the safety of other beach users and provide adequate space to other beach users at all times.



- Another destination for horse riding is the Bass Coast Rail Trail. The Rail Trail is available for horse riders along its total length from Anderson to Wonthaggi. Please contact Bass Coast Shire Council on 1300 226 278 (BCOAST) during business hours for information on horse riding on the Bass Coast Rail Trail.
- Horse riders must give way to pedestrians along the beach access track at the end of Norsemens Road.
- For environmental reasons, horses should only be ridden on the beach below the high tide mark. Horses should enter the water a minimum of 100m to the north of the access track in a location where the intertidal zone has coverage of sand.
- Please remember your horse is your responsibility and horses must be under effective control at all times.
