

LOCAL LAWS FEES 2019-2020

Permit and application fees

*Application fee is only to be paid on application. The permit fee will be invoiced after assessment and approval.

Please note: As of 1 July 2019, footpath trading permit fees are reduced 50% pro rata (excludes application fee) until full fee increase on the 1 January 2020.

A 25% discount (capped at \$500) is offered to all businesses who are current members of a local trader and/or business association. This discount applies to the permit fee only.
